Using the Site, you agree to the terms and conditions of the Terms of Service, including this Privacy Policy. If you choose to visit TRE, your visit to the Site and any dispute that should arise is subject to this Privacy Policy and our Terms of Service, including limitations on damages, arbitration of disputes, and application of the law of the state of Florida. TRE is commit-ted to safeguarding your privacy online. TRE created this Privacy Policy to demonstrate our firm commitment to protecting users' privacy of TRE products and services available through the Site. Please read the information below and any supplemental information referenced in this Policy for additional details about our particular Site. We do not sell, trade, or rent your personal information to other companies or third parties. We use the information we collect about you only to process orders and to provide a more personalized online experience. We will not collect any personal information about you except when you specifically and knowingly provide such information. II. Information we collect from you

For Services, you have to that you register on the Site. During registration, we will ask you to supply information that allows us to identify you personally. This information includes your name, e-mail address, payment information, and other information that will enable us to contact you to provide you with our Services and maintain it. You have to provide additional details to TRE after you have registered.

III. Use of information we collect from you

We store all information that you provide us. We use this information so that we can be in contact with you after you have placed an order on the Site. We also use your information to contact you from time to time to send you additional information about TRE's products and services and so that we can keep you informed about new products and promotions that might interest you. We also use this information to enhance your experience on the Site. For example, we might use the information you provide us to show you specific content that we believe applies to you according to your preferences when visiting the Site or when we contact you. You may choose to stop receiving any future communications from us by contacting us through the "Contact Us" link on our Site. Please indicate your e-mail address and your desire to opt-out of future communications. After you have opted-out of future communications, TRE will not send you unsolicited communications. While using the Site, you can choose not to provide certain information; however, your decision to do so will limit your ability to use many of the Site's features and may inhibit our ability to provide you with our Services. You can update your personal information by logging in to our Site with your e-mail address and password and clicking on 'My Account.'

IV. Use of cookies and web beacons

A cookie is a small piece of data stored in a browser-related file on your computer's hard drive when you use the Services on the Site. Our primary use of cookies is to enable us to recognize your computer each time you return to our Site or use our Service, keep track of your preferences, determine what you have already seen on our Site, and improve your online experience. For example, storing a cookie on your computer allows you to login without typing your registered e-mail address and password. We may also use an e-mail delivery to send e-mails that you have agreed to receive. Pixel tags and cookies are used in those e-mail messages to measure our advertising effectiveness. Third parties, including third-party advertisers, may also set cookies.

Such third parties are responsible for placing and using such cookies and may collect information about you through such cookies. We do not have access to such cookies, control the use of such cookies, or control the privacy policies of such parties. Please also note that certain types of e-mails available through the Services on our Site may automatically log you into the Site and set new cookies when you click on the links in the e-mails and that you may need to manually remove such cookies if you do not want them on your computer. If you do not want cookies stored on your computer, reject cookies by modifying your web browser setting accordingly (each browser is different, so check the "Help" menu of your browser to learn how to change your cookie preferences). However, if you choose to reject cookies, you may not be able to access products and services that we offer that require you to "log in" or "sign in." In addition to cookies, TRE logs standard information such as your IP address and URL from which you came to our Site, and the URLs visited on our Site, which may or may not contain some personally identifiable information. IP addresses are used by your computer every time you connect to the Internet. Your IP address is a number that is used by computers on the network to identify your computer. Our web server automatically collects IP addresses as part of demographic and profile data known as "traffic data" so that data (such as the Web pages you request) can be informed. TRE will not use your IP address to attempt to identify your personal information. Other "traffic data" includes time, the type of web browser used, the operating system, and CPU speed. This information is sent automatically by your web browser when you connect to a web site.

V. Protection of collected information

TRE uses security systems and secure servers to protect your information. For example, your personal information is password protected so that only you may access or change the information. It would help if you did not share your password with anyone. TRE personally will never ask you to divulge your password in written or electronic communications. We will only ask you for your password when you contact us and only

in cases where you request customer service to correct a service problem that requires your password. Additionally, TRE uses Paypal, a third party, to process all credit card payments. Please be aware that while TRE protects your personal information to the greatest extent possible, Internet security technology changes rapidly, and data transmission is never 100% secure. We cannot guarantee that any safeguards we use will ultimately protect your information from security threats, whether now or in the future.
